EXHIBITION ENTRY FORM AND CONDITIONS OF ENTRY

- **\$7** per **FRAMED** entry:
 - Maximum of three (3) framed entries and one (1) **MUST** be pastel.
 - Only works framed to a **professional standard** accepted.
- **\$10** per entry for works over **ONE SQUARE METRE**:
 - Maximum of six (6) UNFRAMED (two (2) **MUST** be pastel).
- **\$3** per **UNFRAMED** entry:
 - UNFRAMED works must be mounted and presented in clear **cellophane**.
 - Exhibitors required to **SUPPLY** own stands/racks for **UNFRAMED** works.
- **\$3** to enter **CARDS** for sale (maximum of 30 cards):
 - List the **number** of cards, price/title on this entry form.
 - Price in even \$ (no cents), please.
 - **Removable** sticker with artist initials and price on the back of all cards.
 - **NO** other craftwork is allowed.
- At least **TWO** of your works needs to have been completed in the **last year**.
- The other pastels are to have **NOT** been exhibited @SCPS in the last **18 months**. **New** works are preferred.
- To qualify as a “pastel”, work exhibited **must** contain **51%** pastel.
- Paintings to be delivered:
 - On: Opening day from 9:00am until 10.00am.
 - Please ensure all entries are **labelled on the back** with Artist’s NAME, painting TITLE and PRICE.
 - Include the **original** entry form with your paintings at set-up.
- Participants must be available for **ROSTER DUTY**.
 - At least one day (OR 2 half-day sessions) per person.
 - Coordinator is Amanda on 0436357364
- Paintings to be collected not before **4.00 pm**.
- The commission is 20% to SCPS on all sales.
