EXHIBITION ENTRY FORM AND CONDITIONS OF ENTRY

- Entry is open to all **financial members** (only).
- **\$12** per entry <1m² or **\$20** per entry for >1m².
- Maximum of four (4) framed entries & all **MUST** be >75% pastel.
- **ALL ENTRIES** need to have:
 - o **NOT** been exhibited any local **judged** exhibition within the last 2 years.
 - o **NOT** previously won any SCPS prize.
 - o **Original** art only and should be for **sale**.
 - o **Framing** to professional standard.
 - o **LABEL** on the back with Artist **NAME**, art **CATEGORY**, **TITLE** and **PRICE**.
 - o **D-Rings 5cm** from top for hook hang, and
 - o Second set of **D-rings 10cm** from top for wire hanging.
 - o **Model consent** for portraits attached to back of art.
 - o **New** works are preferred.

- o **12 Apr 24:** 1800h. Complete, **Scan & Email:**
 1. **THIS** completed form,
 2. the **ATO** statement by a supplier form (or ABN),
 3. your **PAYMENT** to Treasurer (see page 2), &

 - No late entry forms/payments will be accepted.
- o **13-18 Apr:** Schedule your **Roster Duty:**
 - One full day per person.
 - Coordinator is Amanda at “Amandas of Mogo”.
 - +61 (0)436 357 364 (Closed Wed 17th).
- o **19 Apr 24:** 1100 – 1130h. Bring the **original** entry form.
 - 30-min painting **drop & go**.
 - **Roster Check** your duty at exhibition front desk.
- o **19 Apr 24:** 1130 – 1400 h: Hanging team **ONLY** on the floor.
 - No late deliveries will be accepted.
- o **20 Apr 24:** CLOSED for extra judging time to 1600h (if needed).
 - If judging complete, then **SOFT** opening at 1000h.
 - Preview, raffle & people’s choice votes only.
 - All art (including **SOLD** art) remains in-situ until 21 Apr 24.
- o **20 Apr 24:** 1730h. **OFFICIAL OPENING** including awards & prizes.
 - **Sales** opened. See separate agenda.
- o **21-28 Apr:** Opening times 1000 to 1600h.
 - Please **arrive early** to set up flags, vacuum, tidy etc.
 - You’ll find an **Exhibition Duty Checklist** at the front desk.
- o **28 Apr 24:** Collection of unsold work is **NOT** before 1600h.
 - Your assistance with the pack up/ clean-up of the venue is greatly appreciated.

Prize Categories:

1. Landscapes
2. Fauna & People
3. Flora & Still Life’s
4. Seascapes

Prize Allocation:

- Best in Show 1 x \$500
- 1st per category \$300
- 2nd per category \$200
- Viewer’s Choice \$100

Note:

1. 2 entries per category
2. It is the artist’s responsibility to nominate the category of their work correctly.
3. If only 2 entries in a category, only 1st prize will be awarded.
4. Highly Commended = certificate only.
5. Only one prize will be awarded per exhibitor

• **IMPORTANT STUFF:**

- The **commission** is 20% to SCPS on all sales.
- The **decision** of the judge and SCPS Exhibition Committee is final.
 - o No correspondence will be entered into.
- **Changes:**
 - o **Price and titles** cannot be altered after entry form submission.
 - o **Art** is NOT to be withdrawn from sale during the exhibition.
- **Sales:**
 - o Sold paintings may be delivered to the buyer any time after 21 Apr 24.
 - o Sold paintings may be **replaced** by another painting by the same artist:
 - The replacement will retain the same **identifying number** but separated by an **A, B, C** etc. for Viewer's Choice voting.
 - o Paintings must remain in place until **after** official judging and awards presentations.
 - o The EFTPOS terminal is used for all CARD sales:
 - must include buyers' details and follow the **transaction procedure checklist**.
 - daily **sales registers** MUST be completed accurately, or you will be asked to pay the difference.
- SCPS does **NOT** accept liability for any loss or damage to exhibition entries.
- SCPS retains the right to use any photographs of artworks for **promotional purposes** including but not limited to:
 - o printed publications, website, and social media.
